It is agreed that the Mortgagor shall held and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. Whenever used, the singular number shall include the plural, the plural the singular, the use of any gender shall be applicable to all genders, and the term "Mortgagee" shall include any payee of the indebtedness hereby secured or any transferee thereof whether by operation of law or otherwise.
