Whereas, I, the said Hazel L. Address  
hereinafter called the mortgagor(s)  
in and by my certain promissory note in writing, of even date with these presents, am well and truly  
indebted to The Peoples National Bank of Greenville, S. C.  
hereinafter called the mortgagee(s), in the full and just sum of

as follows: The sum of One Hundred And No/100 (\$100.00) Dollars to be paid on the principal on the 15th day of December, 1951, and the sum of One Hundred And No/100 (\$100.00) Dollars on the 15th day of each month of each year thereafter until the said principal indebtedness is paid in full.

, with interest thereon from date  
at the rate of five (5%) percentum per annum, to be computed and paid

monthly until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness at attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said mortgagor(s), in hand well and truly paid by the said mortgagee(s) at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said The Peoples National Bank of Greenville, S. C., its Successors and Assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the North side of Webster Street in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 3 and a portion of Lots 1 and 2 on plat of Oakland Heights recorded in the R. M. C. office for Greenville County, S. C., in Plat Book B, page 7 (also recorded in Plat Book C, page 147), and having according to a survey made by W. J. Riddle, Surveyor, the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Webster Street, at joint front corner of Lots 3 and 4, and running thence along the line of Lot 4, N. 34-50 E. 150 feet to an iron pin; thence N. 66-49 W. 128 feet to an iron pin on the rear line of Lot No. 1; thence S. 27-45 W. 147 feet to an iron pin in the front line of Lot No. 2; thence along the North side of Webster Street, S. 66-49 E. 109 feet to the beginning corner.
