WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot No. 8 as shown on a plat of Ethel Y. Perry Estate, recorded in Plat Book S at Page 49, and described as follows:

"BEGINNING at an iron pin on the Western side of King Street, joint corner of lots 7 and 8, and running thence with King Street, S. 31-27 E. 65 feet to an iron pin in line of lot 9; thence with line of said lot, S. 65-46 W. 182.5 feet to a point in line of lot 6; thence with line of said lot, N. 9-29 W. 39.5 feet to a point in line of lot 5; thence with lines of lots 5 and 7, N. 54-49 E. 168 feet to the point of beginning."
