WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eight Thousand and No/100- - - - - DOLLARS (\$8000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwest side of Dale Drive, in the City of Greenville, being shown as Lots Nos. 3 and 4, on plat of property of E. Godfrey Webster recorded in Plat Book Z at Page 141, and described as follows:

"BEGINNING at a stake on the Northwest side of Dale Drive, 140 feet Southwest from Ellison Street, at corner of lot No. 2, and running thence with line of said lot, N. 55-30 W. 165 feet to a stake; thence S. 43-39 W. 104.2 feet to a stake; thence S. 55-30 W. 15 feet to a stake; thence S. 63-37 W. 36 feet to a stake at corner of lot 5; thence with line of said lot, S. 55-30 E. 144.5 feet to a stake on Dale Drive; thence with the Northwest side of said Drive, N. 44-15 E. 140 feet to the beginning corner; lot No. 3 having been conveyed to the mortgagor by Maury R. Webster and lot No. 4 having been conveyed to the mortgagor by Ellison G. Webster by deeds to be recorded herewith."
