"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, School District 7 H 2 and being known and designated as lot No. 181 as shown on plat of East Lynne Addition prepared by Dalton & Neves in May 1933, recorded in Plat Book H at Page 220 and being more particularly described as follows:
