TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Archie Means (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fourteen Hundred and No/100- - - - - DOLLARS (\$ 1,400.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as a portion of Lot D at shown on a Plat of the Ansel Arnold Property, recorded in Plat Book A at Page 512, and being more particularly described according to a Plat of the property of J. Ed Means prepared by W. J. Riddle in February 1946, revised June 1949, recorded in Volume V at Page 179, and being more particularly described according to the latter Plat as follows:

"BEGINNING at an iron pin in the railroad right-of-way at the intersection of 23rd Street (now called Farewell Street) and said right-of-way, and running thence N. 81 W. 400 feet to an iron pin in the East side of Church Street; thence N. 11 W. 81.3 feet to an iron pin; thence S. 81 E. 400 feet to an iron pin; thence S. 11 E. 81.3 feet to the point of beginning."

Said premises being the same conveyed to the mortgagor by J. Ed Means, by deed recorded in Book of Deeds 290 at Page 104.

The above described premises is shown on the County Block Book at Sheet 234, Block 8, Lot 9A.
