Whereas, I, the said Donald E. Baltz

ing to said plat, the following metes and bounds, courses and distances,
to-wit:

Beginning at an iron pin on the north side of Princeton Avenue at the
joint front corners of lots 47 and 48, and running thence N. 33-10 W.
150 feet to an iron pin; thence S. 56-50 W. 135.8 feet to an iron pin
on a 20 foot unnamed road; thence with the said 20 foot road S. 53-26 E.
159.6 feet to an iron pin at the intersection of the 20 foot road and
