WHEREAS, I the said Rufus C. Woodall

full and just sum of Eight Thousand, Six Hundred and No/100 (\$ 8,600.00)
Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of
Sixty-Three and No/100

NOW KNOW ALL MEN, That I, the said Rufus C. Woodall

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, ac-

cording to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

the said Rufus C. Woodall in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, lying and being on the southerly side of Wilderness Lane within the limits of the City of Greenville, S. C., being known and designated as Lot No. 65, according to plat of Cleveland Forest prepared by Dalton & Neves, May, 1940, including additions to said plat through September, 1945, and recorded in the R. M. C. office for Greenville County, S. C., in Plat Book M, page 137, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southerly side of Wilderness Lane at joint front corner of Lots Nos. 64 and 65; thence along the joint line of said lots, S. 17-44 E. 150 feet to an iron pin at the joint rear corner of Lots Nos. 64 and 65; thence along the rear joint line of Lots Nos. 51 and 65, N. 72-16 E. 60 feet to an iron pin at joint rear corner of Lots Nos. 65 and 66; thence along the joint line of said lots, N. 17-44 W. 150 feet to an iron pin at joint front corner of Lots Nos. 65 and 66; thence along said Wilderness Lane, S. 72-16 W. 60 feet to an iron pin at the joint front corner of Lots Nos. 64 and 65, the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
