(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Three Thousand and No/100- - - - -**

**DOLLARS (\$ 3000.00** ), with interest thereon from date at the rate of **Six (6%)** per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near Anderson Road, known as lots Nos. 52 and 53 on plat of the property of American Bank and Trust Company, recorded in Plat Book F at Page 44, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southwest side of Jamison Street, corner of lot No. 51, and running thence along line of lot No. 51, S. 42-43 W. 180.4 feet, to an iron pin; thence S. 46-32 E. 99.4 feet to iron pin, corner of lot No. 54; thence along line of lot No. 54, N. 42-43 E. 192.8 feet to iron pin on Jamison Street; thence with the Southwest side of Jamison Street, N. 53-40 W. 100 feet to the beginning corner."
