with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: Ninety (90) days after date, with interest from date at the rate of Six (6%) per cent, per annum, to be computed and paid quarterly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being shown as Lots Nos. 19 and 20 on Plat of the Property of James M. Edwards, made by Dalton & Neves in April 1948, and having according to said Plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southeast side of U. S. Highway No. 29, at joint front corner of lots 18 and 19, and running thence with line of Lot No. 18, S. 47 E. 325 feet to an iron pin; thence N. 43 E. 200 feet to an iron pin, rear corner of Lot No. 21; thence with the line of Lot No. 21, N. 47 W. 325 feet to an iron pin on right-of-way of Ul S. Highway No. 29; thence with the Southeastern side of said right-of-way, S. 43 E. 200 feet to the point of beginning."
