TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, W. H. Alford

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Forty-Four Hundred and No/100- - - - -** DOLLARS (\$ 4400.00), with interest thereon from date at the rate of **Six (6%)**

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeast corner of Campbell Street and Blythewood Drive, in the City of Greenville, being shown as lot No. 36, on plat of University Circle, recorded in Plat Book Y at Page 111, and described as follows:

"BEGINNING at a stake at the Southeast corner of Campbell Street and Blythewood Drive, and running thence with Eastern side of Blythewood Drive, S. 29-21 E. 45.5 feet to a stake at corner of lot No. 35; thence with the line of said lot, N. 80-57 E. 151 feet to a stake in line of lot 37; thence with the line of said lot, N. 24-56 W. 56.5 feet to a stake on Campbell Street; thence with the Southern side of Campbell Street, S. 83-30 W. 138.2 feet to a stake at corner of Blythewood Drive; thence with the curve of the intersection, the chord of which is S. 27-48 W. 22.1 feet, to the beginning corner."

Being the same premises conveyed to the mortgagor by deed recorded in Volume 451 at Page 385.
