TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Fay L. Link (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto David G. Traxler

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Hundred Ninety and No/100

DOLLARS (\$390.00 ),

with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid: on or before ninety days after date with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid at maturity.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Westerly side of Old Augusta Road, near the City of Greenville, being known and designated as lot 6, according to plat of Air Base Highlands, prepared by Dalton & Neves, Engineers, in August 1948, as recorded in the R.M.C. Office for Greenville County in Plat Book Z at Page 195, and described as follows:

"BEGINNING at an iron pin on the Westerly side of Old Augusta Road at joint front corner of lots Nos. 5 and 6, and thence along the said line of said lots, N. 89-15 W. 110 feet to an iron pin at joint rear corner of lots 5 and 6; thence N. 0-51 W. 50 feet to an iron pin at common rear corner of lots 6, 7, 11 and 18; thence along the joint line of lots 6 and 7, S. 89-15 E. 110 feet to an iron pin on the Westerly side of Old Augusta Road, at joint front corner of lots 6 and 7; thence along said Old Augusta Road, S. 0-51 E. 50 feet to an iron pin at joint front corner of lots 5 and 6, the point of beginning."

Being the same premises conveyed to the mortgagor by David G. Traxler by deed to be recorded herewith.
