NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Elmwood Avenue (formerly Fifth Avenue) being shown as lot No. 63 on plat of Section 1 of Judson MillsVillage, recorded in Plat Book K at Pages 11 and 12 and described as follows:

"BEGINNING at an iron pipe on the West side of Elmwood Avenue, 234.2 feet North of the Northwest intersection of Elmwood Avenue and Williams Avenue, and running thence with Elmwood Avenue, N. 4-30 E. 70 feet to an iron pipe, joint front corner of lots. 62 and 63; thence with the line of lot No. 62, N. 85-30 W. 90 feet to an iron pipe, joint rear corner of lots Nos. 72 and 73; thence with the line of lot No. 72, S. 4-30 W. 70 feet to an iron pipe, joint corner of lots 63, 64, 71 and 72; thence with the line of lot No. 64, S. 85-30 E. 70 feet to the beginning corner."
