NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located in the Piney Mountain Section, on the Northern side of View Point Drive, and being shown as lot No. 1 on Plat of the property of Julia Bell Singleton, made by Piedmont Engineering Service and described as follows:

"BEGINNING at a pin on the Northern side of View Point Drive, at joint corner of property of Julia Bell Singleton and S. P. Batson, and running thence with line of Batson property, N. 35-45 W. 248 feet to an iron pin on unnamed Street; thence with said unnamed Street, N. 81-25 W. 104 feet to a bend; thence with the curve of said street, the chord of which is S. 72 W. 125 feet to pin at cornerof lot 2; thence with line of lot 2, S. 20-25 N. 204.8 feet to iron pin on View Point Drive; thence with the Northern side of View Point Drive 306 feet more or less to the point of beginning.
