| I, C. S. Chandler, of Greenville County, | SEND | GREETING: |

WHEREAS, I the said C. S. Chandler

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Three Thousand, Eight Hundred, Fifty and No/100(\$ 3.850.00 )

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

Thirty-Two and 50/100 - - - (\$ 32.50 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I, the said C. S. Chandler

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in the said note.

Chandler</u> in hand well and truly paid by the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**. at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, known and designated as the northern portion of Lot No. 6 of the property of C. S. Chandler and Carl Long, according to a survey made by Charlie Webb, recorded in the R. M. C. office for Greenville County in Plat Book AA, page 42 and also shown on plat of Piney Mountain Land Company and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on Piney Mountain Road, at corner of property heretofore conveyed to Carl Long, and running thence along a new line through Lot No. 6, S. 67-47 W. 132.8 feet to an iron pin; running thence N. 12-45 W. 118.5 feet to an iron pin; running thence N. 61-52 E. 131 feet to an iron pin on Piney Mountain Road; running thence along Piney Mountain Road, S. 14-46 E. 131.5 feet to an iron pin, the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to C. S. Chandler and Carl Long by Abbie Iler by deed dated August 24, 1951 and recorded in the R. M. C. office for Greenville County in Vol. 441, at page 167, the said Carl Long having conveyed his undivided one-half interest in the above described property to C. S. Chandler by his deed dated March 21, 1952 and recorded in the R. M. C. office for Greenville County in Vol. 453, at page 419."
