NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Green, in Chick Springs Township, lying on the North side of West Arlington Avenue and on the East side of Brannon or Green Street and also on the West side of Lanford Street, known and designated as Lots Nos. 17,18 and 19 on a plat of property known as Westmoreland Circle, recorded in the R.M.C. Office for Greenville County, and having the following courses and distances:

Beginning on an iron pin at the intersection of Lanford Street and West Arlington Avenue, and runs thence along the western side of Lanford Street N. 17.40 E. 200 feet to an iron pin, corner of lot No. 20; thence along line of lot No. 20 N. 70.20 W. 158. 5 feet to an iron pin on the East side of Brannon or Green Street; thence with the eastern side of this street S. 13 W. 143.5 feet to a stake at intersection of this street and W. Arlington Avenue; thence wherewith S. 51 E. 157.8 feet to the beginning.
