BEGINNING at an iron pin, corner of Lot No. 3 and running thence
S. 70.20 E. 150 Feet to an iron pin; thence N. 11.10 E. 50.05 feet to an iron pin; thence N. 70.20 W. 150 feet to Greene threat; thence with said street S. 14.40 W. 50.5 feet to the beginning corner, and being known and designated as Lot No. 4 on plat of property made by H. S. Brockman, Surveyor, for J. N. Finley, being a part of the lot of land conveyed to said J. N. Finley by Mrs. Leila W. Cunningham.
