interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

First National Bank of Easley, its successors and assigns, forever:

"All that certain piece, parcel or lot of land situate, lying and being at the Northeast corner of the intersection of Longview Terrace and Ponce deLeon Drive in or near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 15 on a plat of property of Estate of J. T. Blassingame, deceased, made by Dalton and Neves, June, 1937, recorded in the R.M.C. office of Greenville County, South Carolina in Plat Book J at page 117 and having, according to said plat and a recent survey made by R.E.Dalton, November 21, 1939, the following metes and bounds, to-wit: BEGINNING at an iron pinat the Northeast corner of the intersection of Longview Terrace and Ponce deLeon Drive and running thence with the north side of Longview Terrace N64-30 E 70 feet to an iron pin; thence with the line of Lot No. 16 N26-13 W 175 feet to an iron pin; thence with the line of Lot No. 21 S64-30 W 70 feet to an iron pin on the east side of Ponce deLeon Drive; thence with the east side of said drive S26-13 E 175 feet to the BEGINNING corner.
