"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, lying on the North side of James Street, being shown and designated as a part of Lot No. 7 on a plat of property made for I.M. Wood by H.S. Brockman, Surveyor, dated December 31, 1928, and having the following courses and distances: BEGINNING on an iron pin on the northern edge of James Street, joint corner of lots Nos. 6 and 7 on said plat, and runs thence a new line N. 11.17 E. 191.7 feet to an iron pin on line of Lot No. 2; thence with the dividing line of Lots Nos. 1,2 and 7 N. 82.25 W. 55 feet to an iron pin, joint corner of Lots Nos. 1,7 and 8; thence with the dividing line of Lots Nos. 7 and 8 S. 11.17 W. 180.1 feet to an iron pin on the northern side of James Street; thence therewith S. 73.21 E. 55 feet to the beginning corner, and being all of that property conveyed to me by R.B.
