"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northeastern side of Parker Road, near the City of Greenville, shown as lot No. 2 on plat of property of J. Clark made by Dalton & Neves in August 1930, and described as follows: (said plat recorded in Plat Book H at Page 175)
