encumbrances over or against same prior to this mortgage.

It is understood and agreed that the failure of the mortgage or to pay any installment of taxes, public assessments or insurance premiums, when due, shall constitute a default, and that the mortgages may, at their option, foreclose this mortgage or pay said items and add the same so paid, to the principal amount of the debt, and they shall bear interest at the same rate.

This conveyance is made subject to an easement of right-of-way Twenty (20) feet wide extending from Highway No. 291 along the western side of the said lot above described, to the southern line of Lot No. 5, for the purpose of ingress and egress from said Lot No. 5 to said Highway No. 291.
