"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of the intersection of Bramlett Road and Agnew Road, near the City of Greenville, being shown as lot Nol 5 on plat of the property of J. H. Bayne made by W. M. Rast in November 1927, recorded in the R.M.C. Office for Greenville County in Plat Book H at Page 100, and described as follows:

BEGINNING at a stake on the Southern side of Agnew Road, 225.1 feet West from a 20 foot street at corner of lot No. 4, and running thence with the line of said lot, S. 10-52 W. 104.2 feet to a stake in line of lot 6; thence with the line of said lot, N. 61-49 W. 39.5 feet to a stake; thence continuing with the line of said lot, N. 33-17 W. 63 feet to a stake on Bramlett Road; thence with the intersection of said Bramlett Road and Agnew Road, N. 72-12 E. 98.8 feet to the beginning parmer.
