"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 8-AB, being known and designated as Lot No. 22, of Section 6, of a subdivision of the Judson Mills Village, as shown on plat thereof made by Dalton & Neves, Engrs., in November of 1941 and recorded in the R. M. C. office for Greenville County in Plat Book K, at pages 106 and 107, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of E Street at the corner of Lot No. 23, which point is 332 feet north of the northeast corner of the intersection of Fifth Street and E Street, and running thence along the east side of E Street, N. 1-37 W. 70 feet to an iron pin at the corner of Lot No. 21; thence along the line of that lot, N. 88-23 E. 187 feet, more or less, to an iron pin on the bank of Brushy Creek, said pin being off-set from the center of said creek; thence along the center of said creek as the line, S. 23-37 E. 75.5 feet to the center of said creek, iron pin being off-set from the center of said creek on the west bank; thence along the line of Lot No. 23, S. 88-23 W. 215.3 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
