TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Perry L. Bruce

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-Two Hundred Fifty and No/100- - - - DOLLARS (\$8250.00), with interest thereon from date at the rate of Five and One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing one acres, more or less, on the Eastern side of Geer Highway # 276, and bounded by lands now or formerly of W.T. Newby, Nannie K. Hunt, et al being more particularly described as follows:

"BEGINNING at a stone on Geer Highway, and running thence N. 65 $\frac{1}{2}$ E. 3.79 chains to iron pin; thence N. 31 W. 2.80 chains to iron pin; thence S. 65 $\frac{1}{2}$ W. 3.79 chains to an iron pin on the East side of Geer Highway; thence with said Highway, S. 31 E. 2.80 chains to the beginning corner." Being the same premises conveyed to the mortgagor by W.T. Newby by deed recorded in Volume 193 at Page 211."

ALSO, "All that other parcel of land in the State and County aforesaid, known and designated as lots 6 and 34, as shown on plat of Nannie K. Hunt Estate, recorded in Plat Book AA at Page 134, and described as follows:

"BEGINNING at an iron pin in the Western side of Geer Highway # 276, joint front corner of lots 5 and 6, and running thence along the line of lots 5 and 35, S. 63-30 W. 430 feet to a 36 foot unnamed street; thence with said street, S. 26-15 E. 100 feet to an iron pin at corner of lot 33; thence with line of lots 33 and 7, N. 63-30 E. 435 feet to an iron pin in the Western side of Highway # 276; thence with said Highway, N. 29-30 W. 100 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by Paul L. Gilreath and S. T. Turner, as Trustees by deed recorded in Volume 448 at Page 79.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
