And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note and mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, on the Southwestern side of the Laurens Road and on the South side of Glenn Street, and being the Northern portion of that certain lot shown and designated as Lot 25 on plat of survey made by R. A. Moore, March 1945, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "O", at page 116, and having according to said plat, in part, the following metes and bounds, to-wit:

BEGINNING at a point on the Southwestern side of Laurens Road, at intersection with Glenn Street, and running thence S. 61-53 W. 150.6 feet along the Southern side of Glenn Street, to point, corner of Lot 24 on said plat; thence Southeasterly 78.3 feet along the line of Lot 24, to a point in line of Lot 24; thence Northeasterly along the line of lot heretofore conveyed by Florence Hillhouse to Leake, 188.6 feet to point on Southwest side of Laurens Road, which point is 88.5 feet Easterly from point of beginning; thence along the Southwestern side of the Laurens Road, in a Westerly direction, 88.5 feet to the point of beginning.
