"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being a portion of Lot No. 7 of the property of Analane C. Gibson according to a plat thereof recorded in the R. M. C. office for Greenville County in Plat Book AA, at page 110, and also being known and designated as Lot No. 7-B of the property of H. C. Gibson according to a plat thereof prepared by C. C. Jones, Engineer, in June, 1952 and recorded in the R. M. C. office for Greenville County in Plat Book CC, at page 83, and having, according to the latter plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwestern side of White Oak Drive at the joint front corner of Lots 7-A and 7-B, which pin is 70 feet southeasterly from the intersection of White Oak Drive and Carmel Street, and running thence along the joint line of Lots 7-A and 7-B, S. 54-25 W. 140 feet to an iron pin on the line of Lot No. 8; thence along the line of that lot, S. 40-37 E. 59 feet to an iron pin at the rear corner of Lot 7-C; thence along the line of that lot, N. 55-18 E. 140 feet to an iron pin on the southwestern side of White Oak Drive; thence along the southwestern side of White Oak Drive, N. 40-37 W. 61 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to me by R. K. Campbell, et al. by deed recorded in the R.M.C.
