"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying and being on the Southwesterly side of Green Meadow Lane, near the City of Greenville, South Carolina, being shown as Lot No. 7 on the plat of North Meadow Heights as recorded in the RMC Office for Greenville County, S. C. in Plat Book "W", page 183, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Green Meadow Lane at a point 160 feet Northwest of the Southwesterly intersection of Green Meadow Lane and Camp Road, said pin being the joint front corner of Lots Nos. 7 and 8, and running thence along the joint line of said Lots S 47-23 W 187.5 feet to an iron pin on the line of Lot No. 14; thence along the line of Lots Nos. 14 and 15 N 39-40 W 86.7 feet to an iron pin, joint rear corner of Lots Nos. 7, 15, 17 and 18; thence along the line of Lots Nos. 18 and 6 N 52-37 E 193 feet to an iron pin on the Southwesterly side of Green Meadow Lane, said pin being the joint corner of Lots Nos. 6 and 7; thence along the Southwesterly side of Green Meadow Lane S 35-0 E 70 feet to the point of beginning.
