in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the

full and just sum of Four Thousand, Four Hundred and No/100 - - - (\$ 4,400.00) five (5%)

Dollars, with interest at the rate of /s/x/ (6%) per centum per annum, to be repaid in instalments of

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, ac-

cording to the terms of said note, and also in consideration of the further sum of Three Dollars to us Guy Robbins, Boyce Robbins, Wilbur Robbins and Jack G. Robbins, doing the said / business as partners under the firm name of Robbins Brothers in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Town ship, on the east side of the Augusta Road (U. S. Highway No. 25) about four miles south of Greenville Court House, being known and designated as the southwestern portion of Tract No. 7 of the property of Eva Chandler as shown on a plat thereof recorded in the R. M. C. office for Greenville County in Plat Book H, at page 188, and having the following metes and bounds, to-wit:

''BEGINNING at a point in the center of the Augusta Road (U. S. Highway No. 25) at joint front corner of Lots Nos. 6 and 7, and running thence along the joint line of said lots, N. 89-00 E. 200 feet to an iron pin on the line of other property belonging to the mortgagors; thence along the line of other property belonging to the mortgagors, N. 1-00 W. 80 feet to an iron pin; thence S. 89-00 W. 200 feet to a point in the center of the Augusta Road (U.
