NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on gink the Southern side of Traynham Street, just out side the incorporate limits of the City of Greenville, being shown as all of lot 18 and the Western half of lot 17 on plat of Augusta Knoll, recorded in Plat Book R at Page 7, and when described as a whole has the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southern side of Traynham Street, at the joint front corner of lots 19 and18, and running thence with line of lot 19, S. 1 E. 90 feet to iron pin; thence N. 89 E. 75 feet to iron pin in center of rear line of lot 17; thence through line of lot 17, N. 1 W 90 feet to iron pin on Traynham Street; thence with the Southern side of Traynham Street, S. 89 W. 75 feet to the point of beginning."
