"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in the City of Greenville, on the Western side of Palm Street in the section known as Nickletown, and being shown as Lot No. 18 on Plat of the property of Sumlar Hall, made by Pickell and Pickell, Engineers, in May, 1950, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Palm Street at the joint front corner of Lots Nos. 17 and 18, and running thence with the line of Lot No. 17, S. 86-24 W. 105.4 feet to an iron pin; thence N. 3-49 W. 50 feet to an iron pin; thence N. 70-45 E. 111.6 feet to an iron pin on the western side of Palm Street; thence with the Western side of Palm Street, S. 1-53 W. 80 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to me by Jeanne D. Threatt by deed of even date herewith, not yet recorded."
