and construct a cement block dwelling house of Six rooms, and other improvements, on the said described property, and said funds are so being actually used for said purpose and for no other purpose, and this is a construction mortgage.

It is understood and agreed that the failure of the mortgagor to pay any installment of taxes, public assessments or insurance premiums, when due, shall constitute a default, and that the
mortgagee may, at his option, foreclose this mortgage or pay said
items and add the same so paid, to the principal amount of the debt,
and they shall bear interest at the same rate.

TO HAVE AND TO HOLD all and singular the said Premises unto the said John A. Park, his

Heirs and Assigns forever. And I do hereby bind myself, my

Heirs, Executors and Administrators to warrant and forever defend all and singular the said

Premises unto the said John A. Park, his

Heirs and Assigns, from and against myself and my

Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same or any part thereof.
