(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Hundred Sixty-Two and 90/100

DOLLARS (\$762.90),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$42.40 on February 8, 1953, and a like payment of \$42.40 on the 8th ay of each month thereafter until paid in full, with interest thereon from date at the rate of six (6%) per cent, per annum, to be computed and paid semi-annually in advance

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Cleveland Township, adjoining lands of Furman Pritchett, Charlie Laws, Florence Story, W. M. Laws and others and described as follows:

*TRACT 1. BEGINNING at an iron pin on a settlement road, and running thence N. 85 E. 1 chain to a bend; in road; thence S. 47 E. 2.30 chs. to an iron pin in fork of road; thence N. 75 W. 2.31 chs. to iron pin; thence N. 13 W. 3.33 chs. to the beginning corner, and containing .52 of an acrd, more or less.

**TRACT 2. BEGINNING at an iron pin on a settlemen road, corner of the above lot, and running thence S. 85 W. 92 links to iron pin; thence S. 19 W. 1.66 chs. to iron pin; thence S. 3-30 W. 2.00 chs. to iron pin; thence N. 76-30 E. 2.38 chs. to poplar; thence N. 13 W. 3.58 chs. to beginning corner, and containing .62 of an acre, more or less, and being the same property conveyed to the mortgagor by Gather Laws by deed recorded in Volume 339 at Page 65."
