NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeast side of Alpine Way, shown as lot No. 54 on plat of Central Development Corporation, recorded in Plat Book BB at Pages 22 and 23, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at a point on the Southeastern side of Alpine Way, at joint front corner of lots 53 and 54, and running thence S. 53-08 E. 223.1 feet to pin; thence N. 1-35 W. 89 feet to pin at corner of lot 55; thence N. 51-22 W. 169.5 feet to point on Southeast side of Alpine Way; thence with the Southeastern side of Alpine Way, S. 35-10 W. 75 feet to the point of beginning."
