To All Whom These Presents May Concern:

I, CARL B. HOLLAND,

SEND GREETING:

Whereas, I, the said Carl B. Holland,
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to Central Development Corporation
in the full and just sum of Seven Hundred Six and 6/100 (\$706.06) Dollars
to be paid six months from date, with the privilege of
anticipating payment at any time, said payment to be applied first to
interest and then to principal
with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid semi-annually

until paid in full: all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to

ALL that certain piece, parcel or lot of land in Greenville Township,
Greenville County, State of South Carolina, within the corporate
limits of the City of Greenville, and being known and designated as
Lot Number 127 of the Property of Central Development Corporation ac-

County in Plat Book BB at Pages 22-23, and having the following metes
and bounds, to wit:
