"BEGINNING at an iron pin on the southwest side of Blythwood Drive at the of Lot No. 20 as shown on said Coward plat, which point is 60 feet, more or less, from the point of curvature of the intersection of Carmel Street, said point being the corner of the lot heretofore conveyed to Boyce Calmer Kay; thence along the line of that lot, S. 56-45 W. 144 feet to an iron pin at the rear corner of said lot; thence N. 29-21 W. 80.26 feet to an iron pin at the rear corner of Lot No. 18 on the Coward plat; thence along the line of that lot, N. 56-45 E. 137.74 feet to an iron pin at the corner of said lot on the southwest side of Blythwood Drive; thence along the southwest side of Blythwood Drive, S. 34-00 E. 80 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
