NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Manley Street in the block between North and Pettigrew Streets, in the City of Greenville, and having according to a plat thereof made by W. D. Neves, Engrs., March 11, 1919, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on West side of Manley Street, at corner of lot now or formerly owned by Mr. Verner, and ru ming thence with line of Verner property, S. 73-15 W. 122 feet 5 inches to an iron pin; thence S. 16-10 E. 59 feet to post; thence N. 73-30 E. 122 feet 5 inches to iron pin at west side of Manley Street; thence with West side of Manley Street, N. 16-10 W. 59 feet 4 inches to beginning corner."
