NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lots 19 and 20, Section I, as shown on plat of Woodville Heights, recorded in Plat Book K at Page 274, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the Southern side of 4th Street, joint front corner of lots 20 and 21, and running thence with joint line of said lots, S. 35-05 W. 327 feet to an iron pin; thence S. 46-20 E. 67 feet to point in branch at the rear corner of lot 16, Section I; thence along the meanders of said branch and the rear lines of lots 16, 17 and 18 to an iron pin in the Southern side of 4th Street; thence with said street, N. 70 W. 208 feet to the point of beginning.
