with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$25.00 on June 15, 1953, and a like payment of \$25.00 on the 15th day of each month thereafter until paid in full, with interest thereon fram date at the rate of Six per cent, per annum, to be computed and paid semi-annually in advance

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about 2 miles North of Marietta, in Saluda Township, on Toogloo Road, and described as follows:

"BEGINNING on an iron pin in the center of Toogloo Road, on the Southwest corner and running N. 21-30 E. 1008 feet to stone, joint corner with Johnson and Boone, and running thence S. 57 W. 624 feet to iron pin by a pine tree, joint corner with Lindsey, Baker and E. E. Robinson; thence with Bakers line, S. 30 W. 350 feet to iron pin; thence still with Bakers line, S. 60 E. 249 feet across a country road; thence along said road, S. 30 W. 715 feet to the Toogloo Road; thence with said road, N. 83-30 W. 223 feet to forks of road; thence still with road, N. 34 W. 374 feet to bend in road; thence N. 46-46 W. 157 feet to the beginning corner, containing 18.38 acres."
