(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, state of South Carolina, being known and designated as lots # 4 and 5, subdivision of Lee P. Ramsey's (Paris Mt) as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in plat book S page 117 and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin, joint front corner of lots 3 and 4, subdivision of Lee P. Ramsey's, and running thence S. 48-15 E. 413.8 feet to an iron pin; thence N. 37-15 E. 300 feet to an iron pin, joint rear corner of lots 5 and 6; thence N. 47-45 W. 433.2 feet to an iron pin, joint front corner of lots 5 and 6; thence S. 31-30 W. 286 feet to an iron pin in the line of Lot # 4; thence S. 45-45 W. 28 feet to an iron pin the point of beginning.

The above lots are located on the southeasterly side of Parker Road and are the same conveyed to the mortgagor by James Henry Stroud and Alvata C. Stroud .

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
