WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the Eastern side of Elizabeth Drive, being known and designated as lot 217 on plat of the property of Robert J. Edwards made by Dalton & Neves, May, 1951, and having according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Elizabeth Drive, at the joint front corner of lots 216 and 217, and running thence with the line of lot 216, N. 56-30 E. 207 feet to an iron pin; thence S. 33-30 E. 100 feet to iron pin at the rear corner of lot 218; thence with the line of lot 218, S. 56-30 W. 201.7 feet to an iron pin on Elizabeth Drive; thence with Elizabeth Drive, N. 36 W. 59.2 feet to an iron pin; thence continuing with Elizabeth Drive, N. 37-35 W. 41 feet to the point of beginning."

Being the same premises conveyed to the Mortgagor by deed recorded in Volume 444 at Page 115.
