

All that lot of land with the buildings and improvements thereon, situate on the east side of Summer Street, in the City of Greenville, in Greenville County, S. C., being shown as the rear portion of Lots Nos. 2 and 3 on a plat of the property of Mrs. Nellie H. Mackey, made by R. E. Dalton, Engineer, December 1921, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book F, at Page 20, and having, according to said plat and a recent survey made by R. W. Dalton, May 19, 1953, the following metes and bounds, to wit:

BEGINNING at an iron pin on the east side of Summer Street, said pin being 121.5 feet south from the southeast corner of the intersection of Summer Street and Pendleton Street and running thence along the east side of Summer Street, S. 18-45 W. 50 feet to an iron pin; thence with the line of Lot 4, S. 70-27 E. 102 feet to an iron pin; thence along the line of Lot No. 1, N. 20-20 E. 50 feet to an iron pin; thence running through Lots 2 and 3, N. 70-27 W. 103.4 feet to an iron pin on the east side of Summer Street, the beginning corner.

This is the same property conveyed to the mortgagor herein, Monette A. Schulze, by deed of Louise M. Yeager, et al, dated June 1, 1950, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 411, at Page 101.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said Premises unto the said CAROLINA LIFE INSURANCE COMPANY, its Successors and Assigns forever.

AND I do hereby bind **myself** and **my** Heirs, Executors and Administrators, Successors or Assigns, to warrant and forever defend all and singular the said Premises unto the said CAROLINA LIFE INSURANCE COMPANY, its Successors and Assigns, from and against **myself** and **my** Heirs, Executors, Administrators, Successors and Assigns and all other persons whomsoever, lawfully claiming, or to claim the same, or any part thereof.

AND the said mortgagor doth, as additional security, hereby assign, set over, and transfer to the said mortgagee, all of the rents, issues and profits of the said mortgaged premises, accruing or falling due from and after the service of a summons in any action of foreclosure to which said mortgagee may be parties, and the holder of this mortgage shall be entitled to the appointment of a receiver for such rents and profits as a matter of right, without consideration of the value of the mortgaged premises as security for the amount due the mortgagee, or the solvency of any person or persons liable for the payment of such amount.

AND IT IS AGREED, by and between the said parties, that the said **MONETTE A. SCHULZE** Heirs, Executors, Administrators, Successors or Assigns shall and will insure the house and buildings on said premises and keep the same insured from loss or damage by fire and the perils covered by the standard Extended Coverage Endorsement, and assign the Policy of Insurance to the said CAROLINA LIFE INSURANCE COMPANY, its Successors or Assigns, and in case that **she** or **they** shall, at any time, neglect or fail so to do, then the said CAROLINA LIFE INSURANCE COMPANY, its Successors or Assigns, may cause the same to be insured in its own name, and reimburse itself for the premium and expenses of such insurance, together with interest on the amount so paid, at the rate of six (6%) per cent. per annum, from the date of such payment, under this Mortgage.

AND IT IS FURTHER AGREED AND COVENANTED, by and between the said parties, that until the debt hereby secured be paid, the said Mortgagor, **her** Heirs, Executors, Administrators, Successors or Assigns, shall and will pay all taxes on the property hereby mortgaged, when due and payable, and in case **she** or **they** fail to do so, the said CAROLINA LIFE INSURANCE COMPANY, its Successors or Assigns, may pay said taxes, together with any costs or penalties incurred thereon, or any part thereof, and reimburse itself for the same, together with interest on the amount so paid, at the rate of six (6%) per cent. per annum, from the date of such payment, under this Mortgage.

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if **I** the said **MONETTE A. SCHULZE** do and shall well and truly pay, or cause to be paid, unto the said CAROLINA LIFE INSURANCE COMPANY, the said debt or sum of money aforesaid, with the interest thereon, if any shall be due, according to the true intent and meaning of the said note and conditions thereof and all sums of money provided to be paid by the Mortgagor, **her** Heirs, Executors, Administrators, Successors or Assigns together with the interest thereon, if any shall be due, under the covenants of this Mortgage, then this Deed of Bargain and Sale shall cease, determine, and be utterly null and void; otherwise it shall remain in full force and virtue.
