SEND GREETING:

WHEREAS, we the said Harry R. Chapman and Lucy W. Chapman

in and by OUR certain promissory note in writing, of even date with these presents are well and truly indebted to Roy Waters

in the full and just sum of One Thousand, Three Hundred and No/100 (\$1,300.00) DOLLARS, to be paid at Greenville, S. C., together with interest thereon from date hereof until maturity at the rate of Five (5%) per centum per annum, said principal and interest being payable in monthly installments as follows:

Beginning on the 1st day of September, 1933, and on the 1st day of each month

of each year thereafter the sum of \$ 50.00 to be applied on the interest and principal of said note, said payments to continue THEREAFTER until paid indebtedness is paid in full

~~xxxx~~ the aforesaid monthly payments of \$50.00 each are to be applied first to interest at the rate of Five (5%) per centum per annum on the principal sum of \$1,300.00 or so much thereof as shall, from time to time, remain unpaid and the balance of each monthly payment shall be applied on account of principal.

All installments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any installment or installments, or any part hereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if any portion of principal or interest be at any time past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including (10%) per cent, of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That we the said Harry R. Chapman and Lucy W. Chapman

Chapman, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Roy Waters according

to the terms of the said note, and also in consideration of the further sum of THREE DOLLARS, to us the said Harry R. Chapman and Lucy W. Chapman

Chapman in hand and truly paid by the said Roy Waters

at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Roy Waters, his heirs and assigns, forever.

All that lot of land with the buildings and improvements thereon, situate on the west side of Ridgewood Drive, near the City of Greenville, in Greenville County, S. C., shown as Lot No. 16 on plat of Woodland Hills, made by Dalton & Neves, Engineers, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "Y", at Page 60, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Ridgewood Drive, at joint front corner of Lots 16 and 17 and running thence with the line of Lot 17, S. 73-0 W. 140 feet to an iron pin; thence N. 17-0 W. 100 feet to an iron pin on the south side of Lee Road; thence with the south side of Lee Road, N. 73-0 E. 115 feet to an iron pin; thence with the curve of Lee Road and Ridgewood Drive (the chord being S. 62-0 E. 35.3 feet) to an iron pin on the west side of Ridgewood Drive; thence along the west side of Ridgewood Drive, S. 17-0 E. 75 feet to the beginning corner.

This mortgage is junior in rank to the lien of that mortgage given by Harry R. Chapman and Lucy W. Chapman to General Mortgage Co., in the amount of \$7,700.00, of even date and to be recorded herewith.
