To All Whom These Presents May Concern:

I, BROADUS KILGORE

SEND GREETING:

Whereas, I, the said BROADUS KILGORE
in and by my certain promissory note in writing, of even date with these
presents, am well and truly indebted to Margaret D. Norwood

in the full and just sum of ELEVEN HUNDRED AND NO/100 (\$1100.00) DOLLARS
, to be paid FIFTY AND NO/100 (\$50.00) DOLLARS on the
15th day of each and every month, commencing on the 15th day of
September, until paid in full; payments to be applied first to
interest and balance to principal

, with interest thereon from date
at the rate of Six per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and
unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder
hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be
placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the
holder thereof necessary for the protection of his interests to place and the holder should place the said note
or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the
mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees,
this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said Broadus Kilgore
, in consideration of the said debt and
sum of money aforesaid, and for the better securing the payment thereof to the said Margaret D. Norwood
according to the terms of the said note, and also in
consideration of the further sum of Three Dollars, to me, the said Broadus Kilgore

, in hand well and truly paid by the said Margaret D. Norwood
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bar-
gained, sold and released and by the Presents do grant, bargain, sell and release unto the said
Margaret D. Norwood, her Heirs and Assigns:

All that certain piece, parcel or lot of land in the City of
Greenville, County of Greenville, State of South Carolina, on the
Eastern side of Leach Street, and having the following metes and
bounds, to-wit:

BEGINNING at a point on the Eastern side of Leach Street, which
point is 100 feet South from Arlington Avenue and running thence S.
72 E. 101 feet to a pin; thence S. 18 W. 31 1/4 feet to a pin; thence
N. 72 W. 101 feet to a pin on Leach Street; thence with Leach Street
N. 18 E. 31 1/4 feet to the beginning corner.

Being the Northern half of Lot No. 6 according to a plat recorded
in the R. M. C. Office for Greenville County, S. C. in Plat Book A, at
Page 229.
