"BEGINNING at an iron pin at the southeast corner of the intersection of Hillcrest Drive and McDonald avenue, which point is 42 feet from the curb along Hillcrest Drive, and 11.5 feet east from the curb along McDonald avenue, and running thence along the old line of Hillcrest Drive, S. 66-55 E. 76 feet to an iron pin at the corner of Lot No. 76, which point is 21 feet south of the curb line along Hillcrest Drive; thence along the line of that Lot, S. 19-14 W. 126.7 feet to an iron pin, which thence in a northwesterly direction, in a new line across Lot No. 77, approximately 88 feet to an iron pin on the east side of McDonald Ave., is 50 feet north of the intersection of Mountain View avenue; thence along the east side of McDonald avenue, and along the east side of McDonald avenue, and 11.5 feet distance from the curb, N. 23-32 E. 100 feet to the beginning corner."
