per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin in the middle of a public road at the corner of property now or formerly owned by Sam Raines; running thence S. 38 E. 12.70 chains to an iron pin; thence S. 63½ W. 3.35 chains to an iron pin; thence S. 68½ W. 1.11 chains to an iron pin; thence S. 54½ W. 3.92 chains to an iron pin; thence N. 38 W. 12.00 chains to an iron pin; thence N. 51 E. 8.22 chains to the point of beginning, containing 10 acres, more or less. Being the same property conveyed to the mortgagor by deed recorded in Deed Book 356 at Page 317."

ALSO:

"BEGINNING at an iron pin on line of Woodrow Watson and the joint corner of lands of J. E. Watson and the mortgagor; running thence N. 38 W.  $49\frac{1}{2}$  feet to the Southern edge of the new surface treated Roper Mountain Road; thence running along the Southern edge of the Roper Mountain Road in a Northeastern direction 250 feet, more or less, to the Eastern corner of my one acre tract; thence running with the mortgagor's line. S. 51 W. 245 feet, more or less, to the beginning corner." This being the same property conveyed to the mortgagor by deed recorded in Deed Book 375 at Page 201.
