Hawkins in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, consisting of 3 acres, more or less, and having, according to a plat of property of Edward R. Hawkins prepared by W. A. Hester, L. S., at this time unrecorded, the following metes and bounds, to-wit:

"BEGINNING at a point on the western side of White Horse Road, and running thence N. 84-1/2 W. 11.95 chains to an iron pin in line with property now or formerly owned by Mary Walker; thence along Mary Walker's line, S. 4-1/2 W. 2.08 chains to a point, said point being .99 chains or 60 feet from a stone in line with Mary Walker's property; thence along a new line, said line being .99 chains from the old line according to the above mentioned plat, approximately S. 84-1/2 E. 10.00 chains, more or less, to an iron pin on the western side of White Horse Road; thence along the western side of White Horse Road, N. 32 E. 2.36 chains, more or less, to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the same property conveyed to me by Clara Davis by two deeds, the first being dated November 25, 1941 and recorded in the R.M.C. office for Greenville County in Vol. 239, page 300, and the second being dated December 28, 1946 and recorded in the R. M. C. office for Greenville County in Vol. 304, page 352."
