NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of West Washington street in the City of Greenville, and being more particularly described as follows:

BEGINNING at an iron pan at the corner of lot, formerly owned by Dean on the South side of Washington street, and running thence along the line of said lot $S.19\frac{1}{4}$ W. $217\frac{1}{2}$ feet; thence N.66 $\frac{1}{2}$ W. $79\frac{1}{2}$ feet to a stake; thence in a northerly direction to the center of the circumference of a well, on the Southern side; thence around the Western side of said well to the center on the North side; thence in a Northerly direction to a point on the Southern side of West Washington street, which point is 72 feet from the point of beginning; thence along the Southern side of said West Washstreet $S.66\frac{1}{2}$ E. 72 feet to the point of beginning.
