WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot 17, as shown on plat of property of Helen B. McDaniel, recorded in Plat Book T at Page 21, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin in the Southern side of McDaniel Court (formerly Carroll Street) joint front corner of lots 17 and 18, which pin is 255 feet East of the intersection of McDaniel Court and McDaniel Avenue and running thence with McDaniel Court, S. 62-25 E. 75 feet to iron pin, corner of lot 16; thence with line of said lot, S. 19-12 W. 173.7 feet to iron pin; thence N. 56-41 W. 70 feet to iron pin, rear corner of lot 18; thence with line of said lot, N. 17-00 E. 167.8 feet to the point of beginning. Being the same premises conveyed to the mortgagor by Helen B. McDaniel by deed recorded in Volume 457 at Page 173."
