Todd, Jr.**, do and shall well and truly pay, or cause to be paid, unto the said **South Carolina National Bank of Charleston (Columbia Branch)**

the said debt or sum of money aforesaid, with the interest thereon, if any shall be due, according to the true intent and meaning of the said **note** and all sums of money provided to be paid by the Mortgagors, **their**

AND IT IS FURTHER AGREED AND COVENANTED between the said parties, that in case the debts secured by this Mortgage, or any part thereof, is collected by suit or action, or this Mortgage be foreclosed, or put into the hands of an Attorney for collection, suit, action or foreclosure, or in the event of the foreclosure of any mortgage, prior or subsequent to this mortgage, in which proceeding this mortgagee is made a party, or in the event of the bankruptcy of the mortgagor, or in assignment by the mortgagor for the benefit of creditors, the said Mortgagor ~~s~~, ~~their~~ Heirs, Executors, Administrators or Assigns, shall be chargeable with all costs of collection, including **reasonable** per cent. of the principal and interest on the amount involved as Attorney's fees, which shall be due and payable at once; which charges and fees, together with all costs and expenses, are hereby secured, and may be recovered in any suit or action hereupon or hereunder.
