NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All/Inducertain piece/parcel/or lot/of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being more particularly described as follows:

"TRACT NO. 1: BEGINNING at an iron pin on the Buncombe Road, and running thence in a Westerly direction 105 feet; thence in a Northwesterly direction 105 feet to a stake; thence in an Easterly direction 105 feet to stake on Buncombe Road; thence along the Buncombe Road in a Southerly direction 105 feet to the beginning corner, containing 1/4 of an acre, more or less.

"TRACT NO. 2: Adjoining the above described tract and being more particularly described as follows:
